- Key Agenda item covering Legal considerations, Archdiocese engagement (meeting held 8<sup>th</sup> November with EDC Catholic representative and St Andrew & St Joseph parish clergy), ongoing communication and public meeting attendance.
- In addition to publishing the updates to the St Nicholas website we are also proposing to join up with PA to create a joint facebook page.

# Milngavie & Bearsden Public Meeting 13th November

- A huge thank you to all who attended the Public meeting at Bearsden Academy on Wednesday 13th November where we enjoyed a full house. I believe that all of our points were put across and are well understood by the Education Department.
- There was also attendance from parents/schools out with Milngavie & Bearsden who raised their own objections as well as local councillors.
- For those unable to attend there is a further public meeting at Bishopbrigg's Academy on the 25<sup>th</sup> November at 6.30pm
- ➤ Topics covered included local school provision, cluster and continuous education, proximity to local school, planned housing prioritisation, fraudulent catchment requests, education estate management, clarification on the consultation itself, special associated placing requests e.g. sports, Gaelic & music provision and placing request clarification.
- Please note that it is EDCs intention to engage the pupil council for their view and the school will be in touch shortly with both parents and children. This is standard practice for consultations.

## **EDC Parent Council Forum 18th November**

- > The Parent Council Forum convened on the 18th November at Kirkintilloch High School.
- Key Agenda item was Admissions consultation. Attendees represented schools from all EDC catchments.
- ➤ EDC acknowledged close and early engagement with St Nicholas.
- As part of the Education Scotland report preparation there may be the opportunity for parent council representation and we have requested that we be part of that group given our circumstances. This is to be confirmed however EDC are amenable to us participating and will confirm in due course.
- Topics covered were similar to those at the public meeting.

## What can you do?

- 1. As before please complete the consultation with our recommendation to reject based on the points below (feel free to add any others) by the 6<sup>th</sup> December
  - Our lack of local catholic secondary school provision setting us apart from the rest of the EDC Estate and our right to a local education
  - Potential detriment to new St Nicholas school intake and potential transfers out resulting in oversubscription to local non-denominational primary schools and a significantly under populated new £10m school.

- Impact on current P7s expecting to move under existing catchment policy to local secondary school and proposal to delay implementation if approved to following year.
